Fourteen years later, what better time to celebrate the 100th Anniversary of Gar Wood production, and what better place than Obexer’s Boat Company! Obexer’s is the original Gar Wood dealership since 1928 and is the oldest active marina on Lake Tahoe.

*With the unique slip arrangement at Obexer’s Boat Company, we ask that you take an accurate beam measurement (at the widest point of the hull) and note it on this form.*

These photos and your other documentation will be used to decide if your boat is *Concours* quality. AND, these photo(s) will also be used in the 2025 commemorative program. *(Note: Trailer shots and low resolution or poor-quality images will not be included in the printed program.)*
